6. Principals Account of Learning- Presentation

Each of our Building Principals gave a presentation on current learning pros and cons. The first two weeks just getting back into school and building those relationships, after being out of school for all of six months.

Elementary- Happy Kids, compliant, good environment. Students are pretty much doing what they see their peers doing. Plans in place if needed to go full virtual. Mask breaks are provided, spacing is provided for learning areas, lunch areas, work areas. Technologies are used to communicate with all students, traditional and Virtual. Finding a balance of teacher time with virtual and face to face can be challenging. Professional staff is glad to have kids back even with the challenging times for teaching

Middle School- Kids and Staff happy to be back and our hoping to stay in school Cohorts are working but with some challenges to maintain a balance and consistency in learning. Assessments are changing, Health room wearing of masks are working out well. PPE in place in Covid Isolation area. Plans in place if having to go Virtual. Good records are being kept following with the at home students time of learning as well virtual leaning. Student to teacher contact. Challenges are in focus time, and with keeping with the social distancing. Virtual music and band lessons are taking place with the technology that allows kids even at home.

High School- kids and staff are so glad to be back face to face. Cleaning and sanitizing protocols are being followed to mitigate pandemic. Contract tracing is working, lot more. Hands on, using resources and tools in hand. Relationship building has been amazing as the teachers are getting to know their students. Some of the struggles with the staff has been pacing/planning, using the best resources available, taking the at home time seriously. Also with parents/ guests and the community and the importance of following protocol for safety reasons with this pandemic. CAPP programs or working the University to assure the proper benchmarks or learning is taking place for getting proper crediting.

While the presentations took place from each building principal community members in attendance could ask questions surrounding the safety and learning for their child. Some of the questions were asked about efficiency, safety of allowing outside guests in buildings or at sporting events when parents aren't allowed to come in buildings or attend games. Safe environment for learning is our concern, of course wanting normalcy but who knows when that will be. There are no definite answers as to whether we will have to go complete virtual. Risk levels change, following PPE, Health Department, American Pediatric will be a part of change, that will be looked at when different models of learning will be determine

7. Moving through the Models of Learning- Discussion

Virtual learners: We explained to the families that chose to have their child(ren) learn virtually, it would be at least a semester commitment.

For face to face (Elem) and Blended Learners (6-12): If nothing (more cases, staffing, issues etc.) drives us to change to a virtual model prior to Oct. 19, this is the date we said we would reevaluate our current plan. If there were changes to our current plan, the actual change would take place Nov.9 i.e. going all in person

Criteria for Change: The ability to be at the "Low" level or risk, as of late that is not happening been at the critical point. Masking is being noted as well as social distancing, children are being kept at home if sick, handwashing importance is being acknowledged.

What would drive us to virtual learning for all, one building and/or all buildings: No real answer currently, looking at risk factors, district ratings per our population, staying below even 1 case.

Some factors looked at if we would go virtual: Staffing would be a driving factor, staffing appropriately. If learning and the cleanliness of our buildings profoundly or negatively are impacted due to staff. Currently as of September 10, 2020 we have 24 cases giving us a High rating.

8. Masking Ordinance

Administrator Peggy Larson recommendation is to maintain the governor's mandate of wearing masks in schools for safety and health reasons, even if the mandate is run out as of September 28,2020. The masking for students may be looked at in the future, but as of the current date all of the surrounding school districts have voted to maintain the wearing of masks for trying to mitigate the pandemic. Some questions from those in attendance were, would there be some leniency or allowing no mask wearing for health affects to students or others. Board member Zeller spoke on the importance of continued wearing of masks trying to mitigate the pandemic and maintain the safest environment as possible. Principals response was that mask breaks are being given.

Motion made by Verich, second by La Due to abide by Governor Evers wearing of Mask mandate, extension or not after September 28, 2020.
