7. Moving Through the Models of Learning- (See information on file)

District Administrator Peggy Larsen is not making any recommended changes at tonight's meeting. Plea is being made to the community to help slow the spread of the Covid 19 virus. Currently children are being sent home when ill, or not being quarantined when others in the family are being tested or are already positive. There may be a recommendation to change configuration of cohorts, so students in blended learning can have access to staff without a long gap in between in person days. Will further discuss at 10/16 meeting. Currently, it is not the goal of WCSD to close school or go entirely virtual.
