### 6. Models of Learning

Report of Active Covid cases in the Winneconne Community School District were updated and reviewed, currently as of November 1, 2021, there are no recommended changes to the Models of Learning for all grade levels.

### 7. State Assessment Results

Director of Learning, Don Smith presented Winneconne students state assessments. The Wisconsin Department of Instruction released the State assessment results for 2020-21 year. Winneconne students performed very well despite interrupted learning. Our students have shown significantly higher results as compared to students in our area and across the state of Wisconsin. The assessments were on the Wisconsin Forward Exam for grades 3-8, the Aspire assessment for 9<sup>th</sup> and 10<sup>th</sup> graders, and A.C.T. college admissions test taken by the 11<sup>th</sup> grade students. For a copy of the full assessment go to our district website or a copy may be given by request.

## 8. Budget Revision

Business Manager Monika Knapp reviewed and gave an updated revision of the 2021-2022 budget. Initial publication showed a \$7,789 surplus, we now are projecting a \$94,540 surplus for fund 10. This increase is due to a \$70,856 increase in local aid as well as an increase of \$15,895 in state aid. All other funds remain the same. The final allocation for Esser II funds is \$408,754, compared to the previously projected \$349,770. The district is still waiting on Esser III (aka ARPA) allocations. Please note while the ARPA funds recommend following CDC guidelines for return to school plans, it does not mandate that these guidelines be followed in order to receive ESSER III/ ARPA funding.
