The cost of Hiring School Perceptions would be \$9400. There was concern by the board for the cost of hiring for the survey. Board Member Kunde had been satisfied with the results from the last time we contracted with School Perceptions, as the results and questions were very thorough. Board Member Verich and Keller voiced concern over the high cost related to hiring School Perceptions.
