# **6. Security Update**

Miron staff presented more information on the secure entrances and HS Locker Room renovation. Review of the budget process and where the source of monies would come from within the budget, between fund 46 and fund 10 the dollars in these budgets could cover renovations. The cost estimates for the secured entrances with a 6 to 7% inflationary built in are at \$1,293.499.00. Secured entrance estimates broken down, ES- \$221,157.00, MS-\$99,261.00, HS-\$274,875, and HS Shower room renovations- \$698,207.00

Director of Learning, Peg Mischler presented to the Board the information for the possible Intergovernmental agreement with the Keil Area School District and the Winneconne Community School District, pertaining to the eAcademy. For some students, on-line learning works well, students do not enroll out of our district, they remain our students, and earn our diploma provided they meet all of the WCSD requirements including community service hours. Students are able to participate in extra curricular activities and take up to two classes in the WCSD buildings. The total cost per student for WCSD is \$4350.00(\$4700-\$350.00 Chromebook reduction) =\$4350.00) for full time enrollment, if a student is no longer enrolled and transitions back to WCSD before the end of the first semester, a refund check will be issued for \$1775.55. There will be a mandatory parent meeting virtual (August 10, 2022) for those interested in participating in eAcademy.
