With the options that were presented the discussion surrounded the costs, facility updates, and the possible grade levels at each of the grade level campuses. After lengthy discussion of the seven options presented the Board of Education came to an agreement in support of Option# 2 Middle School Renovation, and Option # 7 Elementary School Addition. Planning going forward will include a possible Community Survey, special meeting for survey questions, and open forum for community residence.

A community survey question night would be held after survey goes out. If the survey indicates that a referendum will be supported, we will draft the resolution(s) in December and vote to support the resolution(s) in January.
