Teacher Compensation model was recently approved, however there was an oversight, teacher's annual salary increase for next year is \$800 (This is the last year of the current model)- However, the HR Committee of the Board wants to be sure the teacher's increase is inline with the support staff increase for the coming year. The HR Committee of the Board is recommending a \$1100 annual salary increase vs. the \$800 for this next contract. The Following year the annual salary increase will be the \$1000 outlined in the new model. So, for school year 23/24 \$1100, 24/25 school year \$1000 and 25/26 school year incremental.
