8. WCSD Policies

Policies # 5460- Graduation Requirements and Policy 5330.01 Administration of Naloxone (Narcan) were reviewed by WCSD Policy Committee for recommendation of approval.

Policy # 5460- Graduation Policy was presented with a language change, the recommended change is to remove the word Intellectual Disabilities (ID) from the policy as IEP's are to drive the graduation requirements, not the disability area. This part of the policy does not apply to regular education students.

Policy # 5330.01 Administration of Naloxone (Narcan) is a new policy. Review of the policy drew some questions on to the accessibility, well in locked conditions or not. The Naloxone will not be under locked conditions, and Staff who will administer Naloxone will be trained annually, and noting in this policy will regulate, restrict or otherwise deter law enforcement officer, emergency medical technician, firefighter, or any licensed medical professional or authorized individual from administering.
