Andy Plachetka and Dr. Zeller presented the outcome of the group that met to review the Wellness Policy and The Human Growth & Development Curriculum. Health is being added back at the high school level. The district will continue to send a letter home two weeks in advance letting parents know which topics will be taught for each grade level. A parent resource guide will be included. Fourth and fifth grade students will now be separated by gender, but will still learn all of the material for both genders.

Motion by Baltus, second by Verich to approve the update to the Wellness Policy and the Human Growth & Development curriculum as presented. Motion approved 6-0

Motion by Hanson, second by LaDue to approve the Joint Resolution between the Village of Winneconne and the Winneconne Board of Education allowing students to participate in Village Committee work. Motion approved 6-0

Motion by Hanson, second by Olson to approve updates to School Calendar as presented. Motion approved 6-0

Policy updates include a review of internet safety. This includes monitoring both at home and at school. Legally, we are required to monitor and report any potential threat. Mr. Sorrells clarified that Mrs. Michaud, Mrs. Cady, and the school counselors all receive an email notification if something triggers an alert. In addition, there is third party notification through Google should something be flagged as an imminent threat.

Graduation policy has been updated to limit adornments that can be worn. This includes eliminating the Gallon Grad cords. National Honors Society, Spanish National Honors Society, and Academic Honors will be the only adornments allowed at ceremonies beginning in 2020.
